The Miami Dade County Motor Vehicle Repair (MVR) Ordinance requires that all mechanics and paint/body technicians MUST earn sixteen (16) hours of Continuing Education each year. The requirement affects mechanics and paint/body technicians that apply or renew their Motor Vehicle Repair Certification on or after January 1, 2000. *La Ordenanza de Reparación de Vehículos a Motor de Miami Dade County requiere que todos los mecánicos o técnicos de pintura y chapistería, obtengan anualmente dieciséis (16) horas de Educación Continua.
